

Board of Directors Meeting Minutes January 12, 2023 11:00am – 12:30pm

Previous Meeting's Minutes

A motion was made by Nick and seconded by Dave to approve the minutes. The minutes from the previous meeting were unanimously approved.

Treasurer's Report - Molly

- Form 990: Wrapped up Form 990 signed and submitted before November 15 deadline; accounting change form also submitted. Millington invoice received and confident they can do our Form 990 for tax year 2022. Nick gave Molly kudos and appreciation for her work getting Form 990 submitted on time
- Financial Report: FY23 donations to date = \$290,596 (from Joanna's report). Did not get the same spike in year-end donations as in previous years. Expecting a big P3 to come through similar to the previous year. Micron funds are coming at different intervals than the past. Data shows there are corporate funding changes from the initial pandemic years (FY21, FY22). Lots of competition for corporate donations

Current Business and Foundation Updates – Joanna, Marney, Elizabeth

- Grants Update & Recent Awards presented by Marney and Elizabeth. Awarded and Program Allocation \$23,000 received were discussed, in addition to those not awarded, awaiting notification, and those to be Submitted
- Donor Development presented by Joanna: Year-End Donations (thank you!) raised \$6,315 through mostly unrestricted, individual gifts made to STEM AC. Volunteer efforts included Hour Of Code with 85 volunteers from 15 companies at various schools, the largest volunteer effort we have supported. Program Sponsorships 2023 are open. STEM AC is also now seeking support for the Ecostystem convening in addition to student and PD programs.
